EXPLANATORY NOTE

Zoom Video Communications, Inc. (the "**Registrant**") is filing this Registration Statement with the Securities and Exchange Commission (the "**Commission**") to register (i) 14,691,142 additional shares of its Class A common stock under its 2019 Equity Incentive Plan (the "**2019 Plan**"), pursuant to the provisions of the 2019 Plan providing for an automatic increase in the number of shares Class A common stock reserved and available for issuance under the 2019 Plan on February 1, 2023 and (ii) 2,938,228 additional shares of its Class A common stock under its 2019 Employee Stock Purchase Plan (the "**2019 ESPP**"), pursuant to the provisions of 2019 ESPP providing for an automatic increase in the number of shares of Class A common stock reserved and available for issuance under the 2019 ESPP on February 1, 2023. In accordance with the instructional note to Part I of Form S-8 as promulgated by the Commission, the information specified by Part I of the Form S-8 has been omitted from this Registration Statement.

Pursuant to General Instruction E of Form S-8, the contents of the Registration Statements on Form S-8 filed with the Commission on April 23, 2019 ([File No. 333-230997](#)), March 20, 2020 ([File No. 333-237348](#)), March 18, 2021 ([File No. 333-254444](#)) and March 8, 2022 ([File No. 333-263354](#)) are hereby incorporated by reference in this Registration Statement to the extent not replaced hereby.
