- 25. The shares subject to the option vest in monthly installments as follows: approximately 1,577 shares vested on October 24, 2018 and approximately 1,577 vested on the 24th day of each month thereafter through and including December 24, 2018, approximately 8,207 shares vest on the 24th day of each month thereafter through and including December 24, 2011 and approximately 7,472 shares vest on the 24th day of each month thereafter through and including September 24, 2022.
